## **Summary**

He is a civil practitioner with particular expertise in private & social housing and in representing local authorities in actions for injunctions, committal and closure orders under the Anti-social Behaviour, Crime & Policing Act 2014.

Oliver is also experienced in commercial disputes, credit hire, equine disputes and Animals Act litigation.

# **Professional Experience**

### **HOUSING & LOCAL AUTHORITY:**

Oliver is an experienced practitioner in both private and social housing possession claims, for which he predominantly receives instructions on behalf of Claimants to provide advice, representation and settle pleadings.

He has a particular academic interest in public law, which he lectured at the University of Leicester, and is regularly instructed in cases involving public law and Equality Act 2010 defences. Oliver is accustomed to dealing with cases involving the finer technical points of housing law.

Oliver has significant experience in proceedings on behalf of local authorities, housing associations and the police in relation to anti-social behaviour and is routinely instructed to seek injunctions, committals and other orders pursuant to the Anti-Social Behaviour, Crime and Policing Act 2014.

Instructions are frequently received for Oliver to advise and settle pleadings on the use of injunctions to regulate conduct, not just in relation to individuals and properties, but also wider areas such as town centres.

The Police have also instructed Oliver to seek Domestic Violence Protection Orders pursuant to the Crime and Security Act 2010 and injunctions under the 2014 Act.

Oliver is also experienced in claims for unlawful eviction, navigating the complex case law and statutory framework associated with those high value claims.

#### **COMMERCIAL & ANIMAL LITIGATION:**

Oliver is regularly instructed to settle pleadings, advise and represent clients in contentious commercial disputes arising from both business to business and consumer contracts.

He has considerable experience in dealing with a range of commercial disputes; including claims founded upon contracts for the sale of goods and/or services, building disputes, sale and installation of defective machinery, negligent references and the purchase of vehicles which are said to have been stolen.

Oliver has a particular academic interest in contract law, which he lectured at the University of Leicester. He offers clear, concise and comprehensive advice, sympathetic to the wider commercial interest of the client.

Oliver also has experience in contractual claims with significant personal importance, including major events such as weddings or holidays where enhanced damages may be sought for distress or loss of enjoyment.
